Question	Answer
1 What do you mean by "100% based on Kauai"? Does this relate to the organization and/or the project? E.g., Can a nonprofit with its office in Honolulu and projects on neighbor islands qualify?	The PROJECT must be 100% based on Kauai. The non-profit can be on any island.
2 We would apply for funding four our season which begins in July 2025 and ends in June 2026. Should we apply for funding for specific concerts within the season to be funded by the grant?	Yes, the event(s) need to take place during the contract period (thru April 30, 2026). There is also available funding through HTA for any additional funding.
3 Are honorarium's eligible expenses to pay cultural experts, kupuna, etc. for their time?	Absolutely
4 To be eligible, does a project have to show economic benefit whether now or in the future? Would a project that is purely educational for residents qualify?	Yes, it would qualify.
5 Are you using Amplifund?	NO! We are using SMAApply (links in the RFP)
6 Is a separate work plan document required? Or is the quarterly breakdown in the application sufficient?	The Quarterly breakdown in the application is sufficient.
7 Do the Bylaws, COG, etc. have to be only 1 file lumped together?	No, there are separate uploads for each document
8 Can you explain the admin fee for 10% on a simple \$10,000 grant amount. Total ask being \$10,000, does that mean tracking and showing \$1,000 in Grant Admin fee, then the rest of the grant expenditures are \$9,000?	If you are asking for \$10,000, then the admin fee maximum is \$1,000. The cash and in-kind works the same way. (For a \$10,000 grant - \$1,000 cash math (minimum), \$1,000 in-kind (minimum) for a \$10,000 funding request so net to you (assuming you do the minimum) for expenses would be 70% or \$7,000).
9 Can grant funds be used to cover hospitality costs related to cultural exchange activities, such as meals for visiting performers or special guests?	Yes, but travel costs are discouraged.

Collaborative Partners as used in this application relate to someone you are collaborating with outside your organization that is working with you on this Grant Application.
12	If bylaws state who is authorized, do we need to have the Resolution as well?	No. As long as it is clear in the By-laws who is able to sign contracts on behalf of the Organization
13	By adding someone in that Collaborative Partner, do they have to submit work or documents as well? Or just vouch for the project?	No, for the purposes of this grant, a Collaborative Partner is someone who is helping to fill out this grant application. 21	In regards to Admin personnel listed on the Grant Application Project Budget. Grant admin is obviously Admin. However, we are wondering about personnel that are directly involved with running and operating the event? Can we put these people under Operations? Are there any typical line items you would for sure see as Admin or Operations specifically?	Personnel and staff that are directly related to running the project/event can be listed under operations. This amount should only include the portion of time and salary that is directly association with the operation or administration of the project/event.
22	As we are lining out the budget for the event weekend we are submitting for, we recognize we have two options: there is a Trail Run event one day as well as a Luau the next day. Are we allowed to submit 2 grant requests if we fill these out separately since they are for different events? Or is it just 1 per organization per grant cycle?	You can apply as many times as you like, for as many events as you like.
